Treasurer's report: \$5979.66 in checking. MMS to accept as read. So voted.

Bills to be paid: \$66.00 for postage stamps. MMS to be paid in the usual manner. So voted.

Reports of Committees: Radio; Discussion on Old Saybrook Ambulance toning on both 46.18 and 46.04 infrequently. President Johnson to call either Wayne Wysocki or Bill Rochette to inquire. Also they are looking for a chairman for the radio committee in upper Middlesex County. Fire County.

New Business: Deep River has new chief officers: Les Demming 5-0, Jim Budney 5-0-1, Tim Camire 5-0-2, and Tim Ballentine 5-0-3. Killingworth also has new chief fficers: Richie Bauer 8-0, Fred Dudek 8-0-1, Arnie Moore 8-0-2, Jamie Clark 8-0-3.

Interest to the organization: Essex has completed the Q license program. Killingworth will be ordering waterhole signs, anyone who needs some call an officer. Deep River reported the Southbury ladder truck they are looking at is certified and passed everything. The truck might be in service on Sept. 30<sup>th</sup>. Essex reported the ladder truck they are looking at is going for the long haul for inspections. Killingworth spoke of their progress with the possibility of up to \$1000.00 abatement tax. They are working well with their selectman. Essex spoke of their point system for their pension plan.
