Interest to the organization: Discussion was held on looking for speakers to come to meetings. Jim Budney spoke of a call with an electrical transformer pole fire. He spoke of the CL&P people are not trained to put out fires. Dave Heiney spoke of Old Saybrook to start up a support division Which will recreate positions that are not firefighter duties. He stated they are looking for suggestions such as fire police duties; that sort of idea. Tim Camire spoke of a spaghetti dinner at St Joseph's Church To raise money for a little girl's eyesight on Friday November 5th.
