MINUTES OF THE HADDAM MEETING ON JUNE 25, 2001

Oscar will be contacted to handle Morgan and the custodians' etc. MMS to send Oscar a check for \$150.00 for holding Morgan for the seminar. So voted. Also discussed were keeping the seminar mostly for Valley Shore towns and then go to outside departments.

Old Business: Photo copies were handed out of all three committees reports to look over and discuss and vote on at the July 23rd meeting in Killingworth.

New Business: Fred spoke of Andy Flannigan Memorial Scholarship Golf Tournament applications were handed out. \$200,000 was allocated in the governor's budge this year. Discussion followed. Jed is now the new 2nd chair vice president of Middlesex County.

Charlie spoke of East Shore will be putting together an advanced and basic RITT training course on August 25th and 26th.

Interest to the Organization: Don spoke of Rangely Maine is looking for any large diameter hose and appliances. Chester's new Car 7 is in service and their tanker is due in December.

David spoke of Old Saybrook has plans for a hands on training day, with no specific date so far to be held at Fireman's field. Looking for 3 additional VS departments to hold 4 separate scenarios of training. Also David spoke of a call for a plane crash in the CT River, and the point of the Coast Guard did not want the FD involved. July 11, OS will have a radio upgrade, but will keep 46.26 for mutual aid and secondary radio traffic. The question was asked if RITT trained firefighters could have some type of designation on their helmets or gear. And July 10th, the juniors are having a fundraiser at the middle school.
