4. Hybrid cars class: Lorenson Auto Group is willing to assist with this class but has requested that we wait until they are settled into their new facility, tentatively October / November 2006. Bob Gerard reported that State Farm has a good training DVD on new car construction and hybrids, he will attempt to secure copies for any departments interested.

#### **New Business:**

- Common Language / Communications: President Fazzino solicited feedback from VSMAI departments regarding the use of common language.
   Considerable discussion ensued, including questions whether we would change truck / officer designations or just call signals. Jeff Heser proposed that we continue to use codes until involved in a multi-agency response.
   Clinton recently had a multi-agency hazmat response where no communication-related issues were reported. Terry Parmelee indicated that most Middlesex County departments were looking to stay with radio codes.
   MMS (True / Bauer) to continue using radio codes for single agency responses, multi-agency responses would utilize common language. Motion carried 14 in favor / 1 against, no abstentions.
- 2. Frequency Naming / UHF Frequencies: Jeff True questioned how VSMAI would be maintaining consistency / control over new UHF frequencies being implemented across VSMAI. Many of the member towns have their own UHF frequencies and Valley Shore Emergency Communications has obtained a number of frequencies with more expected in the near future. It was agreed that a common naming convention should be agreed upon so that there is consistency amongst all departments. Dick Bauer and Gregg Prevost will prepare a preliminary list of known UHF frequencies and their primary use. This list will be reviewed & revised at the September meeting. The goal would be to have VSMAI maintain a single listing of all channels, their names and uses.

#### **Interest To The Organization:**

- 1. Charlie Herrschaft proposed changing the meeting start time from 19:00 to 19:30. MMS (Herrschaft / Hajek) to make this change beginning with the September meeting in Madison.
- 2. Jeff Heser reported that Clinton will be hosting a RIT / Safety & Survival on September 16<sup>th</sup> & 17<sup>th</sup>.
- 3. Bob Gerard asked if there were any EMT classes coming up. Charlie Herrschaft reported that Guilford may be running one in the fall.
