- 3. SOGs: Terry Parmelee reported that Middlesex County Chiefs have adopted new SOGs which mirror the VSMAI SOGs that were recently adopted. Terry thanked President Fazzino and Dick Bauer for their assistance in aligning the two SOGs, this is the first time in memory that both groups have had SOGs that are the same. Hard copies were distributed to all Chiefs present. Terry noted that page 20 of the SOGs deals with Common Language, Middlesex County has agreed to implement common language for 46.18 (which is governed by them), individual departments can decide how to operate on their local / operational channels. Terry Parmelee reported that Middletown Control and KX have converted to common language for their departments. Gregg Prevost reported that Middlesex County is looking for consistency between day-to-day operations and multi-agency responses.
- 4. Frequency Naming / UHF conversion: A draft list of UHF frequencies that was assembled by Gregg Prevost was distributed to the group. President Fazzino tasked Gregg Prevost, Dick Bauer, Harry Hall and Charlie Herrschaft with developing a list of common names for all VSMAI UHF frequencies.
- 5. Middlesex County Schools: No update.
- 6. Minor Firefighters: President Fazzino reported on behalf of John Brady that the State Fire Commission and Department of Labor (DOL) have agreed to guidelines for minor firefighters. The document is with the Commissioner of the Department of Labor awaiting final signature. The current delay in signing apparently has to do with an issue related to "ride-alongs" for police and EMS explorers. Both sides agreed that this would be a living document, with changes allowed upon agreement from both sides.
- 7. Bob Gerard reported that the Madison Hose Company #1 recently held their elections. Bob Gerard was re-elected Chief, Dave Thomas as Captain, Bob Kyttle as Lieutenant and Bob introduced Jim Carson as their new Lieutenant.
- 8. Harry Hall asked if any departments had experience with Fireman's Fund grants. Harry had received some information regarding the program and was scheduled to meet with a rep within the next few weeks. Several departments responded positively that they had been awarded grants in the past and that this was a worthwhile program to pursue.
- 9. Chief Herrschaft reminded all departments of the upcoming RIT weekend in Guilford (November 11 & 12).
