# **Interest to the Organization:**

- 1. President Fazzino distributed an e-mail from April 19<sup>th</sup> that outlined an issue from 2002 where a 14 year old junior firefighter was killed while responding to a fire call on his bicycle. The Federal Appeals Court recently ruled that the Junior Firefighter should not be included on the National Fallen Firefighters Memorial and that the family is not entitled to the \$250,000 in Federal Benefits. The basis for this decision was that State Law limits junior firefighters' activities to training, first aid and clean-up. Since he was not directly involved in the suppression of fires he did not die in the line of duty and is not eligible for benefits. President Fazzino noted that this is another example of why we need to be aware of and follow the guidelines established by the State of CT.
- 2. Tim Ballantyne outlined plans for an expansion of the Deep River Fire Headquarters. Tentative schedule is to obtain necessary approvals & funding during the next year, break ground a year from now with completion one year from that date.
- 3. Steve Olsen reported that Essex will be hosting a Firefighter 1 beginning in mid-September. Details to follow.
- 4. The May VSMAI meeting in Durham will be moved up to Monday May 21<sup>st</sup> at 19:30 hrs due to the Memorial Day holiday.

MMS to adjourn at 20:00 hours (Greeney / Voss).
