New Business:

- 1. Dick Bauer reported that JT Dunn will be putting together a SAFER Grant application on behalf of the OSFD to request funding for a recruitment video and website for prospective members to obtain information. JT has offered to include VSMAI towns in the process, MMS (Hall / Hajek) to endorse JT's efforts and allow JT to reference the benefit to VSMAI towns as part of his grant application. There are no financial obligations to VSMAI or any towns as a result of this.
- Charlie Greeney reported that there will be a joint Valley Shore Fire / EMS / Emergency Management meeting in Chester on July 17th (Thursday) at 7:00 PM. Wayne Sandford, Deputy Commissioner of Homeland Security, will be the guest speaker. All Service Chiefs are encouraged to attend.
- 3. Charlie Herrschaft reported that Guilford will be hiring 4 firefighters, at least one of which will be a Paramedic. FF1, EMT and CPAT required, the written test is scheduled for August 5th. Ads will be going out in the newspapers within a week.
- 4. Charlie Herrschaft asked that the UHF frequency list / names be re-sent.

Interest to the Organization:

- 1. Gregg Prevost provided some feedback on the recent Colchester fire that included responses from several Middlesex County departments.
- 2. Harry Hall reported that Durham's new Gator will be in service shortly and that Durham has started the process to replace their water supply truck (Durham 1).
- 3. Jim Budney reported that Deep River recently ordered their new rescue truck which will be manufactured by Crimson.
- 4. Gregg Prevost reported that Westbrook's new boat is now in service. The boat has a 500 GPM fire pump with a monitor. Training for pilots / crew is continuing. Westbrook's new brush / light rescue truck (4-8-5) will be in service shortly and will be located at Station 2.
- 5. Charlie Greeney reported that Chester's new rescue pumper (7-5-2) should be in service within a month. The new truck has a 1,000 gallon tank / 2,000 GPM pump and will be first due out of headquarters. Engine 7-6-1 (Pierce) will move to the Whelen station.
