Connecticut Canteen is a food service mobile vehicle that operates with volunteers and travels to fire scenes and disaster incidents. The canteen can be activated through Valley Shore Communications. The canteen is based in Wallingford but can travel up to 40 minutes away to fire and disaster incidents. The vehicle is equipped with lights and sirens; however, the vehicle will not travel with lights and sirens to incidents. Mr. Longergan stated fuel donations at fire and disaster incidents would be greatly appreciated when on scene apparatus are being re-fueled. Mr. Longergan are currently planning and setting up the canteen's operation and it's currently a work in progress but the vehicle is up and running and can respond to scenes.

Past Chief Hall of Durham stated valley shore towns using departments outside of valley shore shall be responsible for ensuring those outside department's information is correct for their mutual aid needs and requirements.

Deputy Chief Fazzino, Jr. of Essex opened discussion concerning which apparatus should operate on the water supply channel. The attendees discussed the issue and found the water supply fill site, tankers, water supply apparatus and the water supply officer should be operating on the water supply channel.

Deputy Chief Fazzino, Jr. opened discussion concerning the Fill Site Operations SOP. Discussion ensued with the attendees concerning the use of three-inch water supply lines, manifolds, and water supply connections.

Chief Bauer of Killingworth asked if the document still contained language requiring two truck/tankers being filled at the same time. The document does contain such language and Chief Bauer explained the April 2013 water supply class would teach these tactics and methods to perform such operations.

President Fazzino recommended removing the requirement for using four-inch water supply lines and depending on the water supply delivery one to two trucks will be filled at the same time.

NOTE: Both the Tanker Shuttle SOP and Fill Site Operations SOP documents will be revised and distributed with the revised language.
